Compliance with Rules: Participant agrees to abide by the official rules of the Tournament, the rules of golf as established by the United States Golf Association (USGA), and any additional rules or instructions provided by Tournament officials. 3. Medical Authorization: Participant authorizes Tournament officials to obtain emergency medical treatment if necessary and holds harmless Tournament personnel from any claims arising from such treatment. 4. Media Release: Participant consents to the use of photographs, video, and audio recordings made during the Tournament for promotional, advertising, and informational purposes without compensation. 5. Refund Policy: Entry fees are non-refundable except in cases of Tournament cancellation. No refunds will be issued for no-shows or withdrawals. 6. Governing Law and Venue: This Agreement shall be governed by the laws of the United States of America and the applicable state law where the Tournament is held. Participant consents to jurisdiction and venue in the state and federal courts located within the Tournament's jurisdiction. 7. Severability: If any

provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect. 8.
