### Risk of Loss:

Risk of loss or damage to the vehicle shall pass from Owner to Buyer upon physical delivery of the vehicle. Until such delivery, Owner shall maintain the vehicle in substantially the same condition as at the time of this agreement, ordinary wear and tear excepted.

### Title Transfer and Documentation:

Owner agrees to deliver to Buyer the properly endorsed title, registration documents, and any other documents necessary to transfer ownership at or before closing. Buyer shall be responsible for all fees related to title transfer, registration, taxes, and other governmental charges after closing.

**Odometer Disclosure Statement:**
